### **HIGHWAY REPORT:**

Highway Superintendent Hawley bought a new jag wing for the f-350, Jameson Highway Superintendent from Solon help Freetown crew install jag wing and Preparing other trucks for winter. Mr. Hawley suggested ordering a loader now , but wouldn't be available till April 2023.

Two sealed bids can in for our used equipment. Jameson received both bids the 1994 gradall for \$2,215.00 and the roller for \$600.00. The other offer was Chad Doran at \$700.00 for gradall. Clock rd., Deneve rd. and Irish Hill are on 2023 schedule for road repairs.

## **BOOKKEEPER REPORT:**

Bookkeeper Mackey informed Highway Superintendent he was over in his chips acct. Supervisor will transfer money around to cover costs. A statement was made about needed a salt shed by state requirements. Superintendent Hawley will check into this by calling the state.

Superintendent Hawley will be paid back 2 months' worth of Health Insurance that had been taken out of his pay but insurance had been canceled.
