Monthly reports from the Town Clerk, Bookkeeper, Justice, and Highway Dept. were received and reviewed.

PUBLIC HEARING:

Town Residents had questions about the way the Local Law was written. Not enough detail on specific items deemed junk, abandoned, or useable by residents. Jim Weiss thinks there should be an appeals process, junk being visible from the road is concerning, seen or unseen is there a difference? How to define commercial operations? Jim Weiss pointed out that all commercial operations sites should be reviewed by the Planning Board (Amish store at the top of the Freetown Cross Rds.) and never turn over to the planning board for review. The resident shows concern about no hours being held at the office for residents for permits or questions. Amanda Barber points out that the storage unit's definition / contradicts itself. Mrs. Barber suggested free garbage pick-up for residents. Mrs. Barber was concerned about things that were on a property when purchased now would face the cost of removal. An example would be a mobile home on the property. Amanda Barber is opposed to this law as it is written. The Town Board will discuss this for future action.
