**OPEN FLOOR:** Councilperson Clough read a letter received from John Walsh who was the gentlemen who had set up our webpage. The webpage is currently sitting at go Daddy and it's paid for until 2020. According to John Walsh we should have paid Daniel Bruffy (IT person) \$3 a month. The board members have no recall of such bill being received. He also paid the of \$117.00 for the past 39 months of service. John Walsh has proposal the town hiring him for \$15.00 a month and he would maintain the website with current information. Town has declined this proposal Councilperson Mackey will check with Adam Dennison from Marathon High School on getting a high school student looking to build their professional skills and complete some community service. Councilperson Mackey on creating a new web page.

Supervisor Grinnell send Mr. Doty a letter, on approaching a board member at a public event, in regards to an owned amount of money for a past summer program. Research by Supervisor Grinnell indicates that those summer students didn't resided in Freetown. Mr. Doty was informed by Town Supervisor not to approach our Town members again for town business.

Amnesty day is still set for May 18, 2019, time still pending. The board will discuss at the April 2019 meeting.

Gail Heady inquired about our current Bookkeeper and if we were considering changing. Karen Fritts (Lapeer) Accountant would be receptive to an offer. Supervisor Grinnell commented on the numerus trips to Dryden for bookkeeping. She also expressed concerns on Highway Superintendent using incorrect account numbers on vouchers. Councilperson Mackey stated she would install QuickBooks

General consensus is waiting it out this year and revaluating it in Sept, 2019.

A refurbished craft man 6hp -22in big wheel push mower was purchase for \$85.00 From Ronald Funk of 3 Brink St. Marathon, NY 13803, to help maintain our park and cemeteries. Highway employee offered to pick-up when it was ready.

Monthly reports from the Town Clerk, Justice, Tax Collector and Code Enforcement Officer were received and passed along for review.

**NEW BUSINESS**: Town Supervisor is recommending a heating coil on the edges of the town hall to help prevent ice build-up that leads to a leak in the ceiling. Town Supervisor informed the Board that she made a mistake on depositing funds at the bank, we received a couple of insufficient funds charges, but corrections were made. Town audit set for March 21<sup>st</sup> @6:30pm for the Town Supervisor and Tax Collector.

Councilperson Clough recommend an executive session as passed along a guideline for reasons to have an executive meeting to discuss the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion. Discipline, suspension, dismissal or removal of a particular person or corporation.

Councilperson Clough received an e-mail from Cortland County on re-cycling glass The Cortland County requested to have glass separated as it can be processed as ground cover at the landfill thru deceasing county cost. It is anticipated a change to separate all recycling items by the end of 2019.

Town employee are inquiring about dental and vision insurance. Town board would like to get more information to make a decision from Town Supervisor.

Corelogic is a company that handles properties in escrow through banks who mail out taxes payments for Freetown residents. Mrs. Heady hadn't received them, twice and come to the conclusion that the fed-x man was placing them in the recycling box at the end of her drive way instead of delivering them to her door and placing them on her porch. A formal complaint has been made. Town Supervisor received a check back from the Town of McGraw as it was short \$300.00 for the full payment. A new check was issued for the correct amount.
