# **Code Enforcement Officer:**

Resident Jim Weiss came to question the 13.7% increase in Freetown's Town/County tax bill for 2021. Town Supervisor explained how we raised our budget \$34,000 in highway. Budget was correct.

The summary sheet was incorrect on amount.

Town increase equaled out to be 13.7% increase.

New Bookkeeper Mary Mackey stated Supervisor Grinnell had the wrong monetary figures. Town Board decided for Supervisor Grinnell to contact State Comptroller Office to make them aware of the mistake and what the town is doing about it. Supervisor Grinnell stated this Sept, 2021 she would start the budget and have some material to present to the board.

Town Board will make a decision in February on how much and where to allocate the extra \$34,513.00 over passed budget. Councilperson Clough inquired on behalf of the planning board on if they should get paid for the year due to two meetings in 2020. Conclusion was to pay for the entire year.

Councilperson gave report on community yard sale for 2021 trying for a day in July. Vendor's \$5.00 charge to fund advertising. There will be street parking, Councilperson Clough will received and adhere to regulating by state on covid prevention. Food truck mention no decision was made.

Town would like to see an itemized bill from Homer men's and Boy's on highways clothing allowance (\$250.00) per year.

Becky Bailey former bookkeeper came to finish her term and turn over paperwork to Mary Mackey new Bookkeeper for 2021
